Hello my loves and welcome back to the Aquarian Age Business Podcast. Today I want to talk about a client fave topic and just such a juicy topic when it comes to astrology. And not just business but self-actualization and life. And that is solar return. So the solar return is when the Sun returns to the exact same degree and minute as it was on your birth chart or on someone's birth chart and basically it's right around your birthday.

A new solar return cycle is, because the sun takes about a year to go across the zodiac wheel. But actually the calendar year is not perfectly aligned to the cycle of the sun. So your solar return is the exact moment that the sun returns to the exact degree and minute as it is on your birth chart. Sometimes that actually happens the day before or the day after your birthday just because it doesn't perfectly align with the Gregorian calendar.

But it's basically the beginning of your new solar cycle with your birthday. And this creates a chart. There is a chart that is like a snapshot of where every other planet and luminary and asteroid is placed on that day. So when you have your new birthday in 2026, whenever your next birthday is, it is looking at the moment that the sun returns to the same degree and minute, - and a minute, by the way, is a fraction of a degree. -

on your birth chart as it was the day you were born, obviously. And that, as soon as it reaches that same point, imagine taking a snapshot of where everything else is in the sky on that day of your birthday this year or whenever your next birthday is. So those placements and this chart that is cast based on your solar return is actually something that we can read to see the future and to actually do divination and predictions for your year ahead.

This is so incredibly valuable and so incredibly juicy. The things that I've predicted have truly blown my mind. Multiple pregnancies, multiple engagements, people meeting their divine union partner and marrying them. Exactly the way that was predicted. It's quite trippy. And I remember when I first started doing solar return readings for my friends, this was before I started my

business. And I would just be like, wow, I'm just reading what I'm seeing here. And sometimes I can't believe the things that are coming out of my mouth. But then to see the way that they all came to pass was very, very mind blowing and very shocking.

I'm a huge fan of solar returns as in, doing a solar return chart, taking a look at your chart, doing a reading for it, or just learning to read it yourself because that's one of the most valuable things that you can know. The greatest opportunities and challenges in the year ahead for you, not just based on the calendar year like, oh, in 2026, but based on your solar cycle. So my birthday is in February and I'm recording this right now at the end of December, 2025.

So, in this episode, I'm gonna share with you about my first house perfection year, which is the year that I'm moving out of before I have my next solar return. And I'll say that understanding your solar return is so insanely valuable because your birth chart, your birth chart as in the static chart that you were born with, with your sun, your moon sign, your Venus, all your money placements, all that stuff, really obviously extremely valuable for business because it's telling you, it's the instruction manual for your self-actualization.

It is telling you how to exalt your highest placements and also the obstacles and the lessons and initiations that you're here to learn. It tells you what people love to pay you for. It tells you about your marketing, your message, your brand voice. It tells you about how you're here to make money. It tells you about the greatest healing gifts that you have to offer others. It tells you about your destiny, all these things.

But in that chart, the placements of your birth chart will be expressed and explored in different ways all the time. So what the solar return helps you to see is when is the right time for certain things. And yes, you know, when is a big question when it comes to astrology, because there's also transits that are happening. Within any given year, within any given month, there are certain days, certain power days that are better for launching or putting out certain offers better for certain actions in life and business.

But the solar return tells you in this year to year way, what are the greatest opportunities for you? And that can be so incredibly valuable when it comes to what to focus on for that year, because the potentials of our birth chart are something we'll continue to explore for our entire lives. We're not here to do everything all at once or be everything all at once. And so the solar return helps us kind of orient that within time, the time space continuum, if you will. And it helps us orient that to see, this is the greatest year to explore and express this specific aspect of myself.

One thing in the study of solar return charts is the profection year. And this is rooted in Hellenistic ancient astrology. It is a predictive astrology technique. And I have a previous episode about this before my podcast rebranded as Aquarian Age Business where I talked about my 12th house profection year. Profection years, not perfection, but profection.

Profection years are a 12 year cycle that goes through the houses of the birth chart. So when I was 35, and actually this is based on age because it begins when we are born and it starts with the first house and it goes around. So there's 12 year cycles that are playing out here. So when everyone, when anyone turns 35, they begin their 12th house perfection year. And that is all about completion. It is all about facing shadows. It is about facing escapism and addiction. It is about healing.

And I obviously was aware of that as an astrologer and I dedicated my 35th year to my healing. I went to multiple retreats. Did a dance immersion, by the way, 12th house is also music and sound. I did a dance immersion with a dance group that I have been inspired by for years. They're called Amenti and I flew to the Netherlands to study with them. I did other healing retreats in the year, hot springs, fascia release, internal work, like yoni work and stuff.

I really dedicated to my healing and I scaled back in the time that I was working in my business because I saw that the greatest opportunity would be the things I bring to completion, not the new ambitions that I'm starting. And it would actually be leaning back into my relationship with spirit and into my relationship with my spirituality and my psychic gifts. And I also faced a lot of things around substance use and addictions, including scrolling, shopping, just anything where I was escaping.

And that is one of the shadows of the 12th house, is escapism. So I knew that this out of all these 12 years was one of my highest opportunities for really leaning in and changing my life through dedicating this time and space to diving into all things 12th house. And with my consciousness, with my intention, with my free will, expressing the highest potentials of that house and being willing to face the shadows.

And that year... was challenging. The 12th house year can be very challenging for people. The 35th year can be very challenging for people. I've seen it. I've seen people really struggle with that year because they don't understand how to work with it. They're trying to pressure themselves and push themselves to do things that are actually not necessarily aligned for that year. Now, I'm not saying if you're in a 12th house perfection year that you can't have ambitions

or have achievements because there can be many other things in the solar return that indicate that. But right now we're just talking about the perfection year alone.

And there's a lot of techniques that connect to that, like the Time Lord and the Time Lord's Promise. And that gives more context as well. So I'm not saying that someone cannot have a career-focused 12th house. So I still would say, even if it is a year that you're growing your career, the 12th, your 35th year, the 12th, which is also the 47th and the 23rd year, those are years to really, did I do that math right? I think I did. Those are years to really focus on your spirituality and your healing.

But there could be other placements that indicate career growth. For me, that was not the case. For me, it was like all over my solar return chart, it was talking about healing. Even my South node in my solar return chart, which represents where past life karma is clearing, was in my 10th house of career and success. So there was big karmic clearings happening there. And the North node, which is where I was being pointed to to follow my destiny. And what I'm speaking on here is in the solar return chart.

So in your birthday chart, in my birthday chart, not my actual birth chart, but my new solar cycle chart. It had the North node in the fourth house, which is all about lineage and roots and the womb. So I did a lot of womb work during that year as well. And I just really listened and I saw the greatest opportunities on that chart. And that's what I dedicated myself to in my 35th year, which was my 12th house perfection year. There's an episode about that. If you scroll back in the podcast, that is probably called 12th house perfection year or something like that

So that was then, but I am now in my first house perfection year and as a 36 year old. So part of why it was so important to me to go all in on my 12th house perfection year is because the 12th house is the final house. It is the end of the house system that comes before a new beginning. So it is the house of completion.

I know that the deeper we allow things to complete, the more we allow processes to complete and dedicate ourselves to that, the greater the new beginning that is on the other side of that. So I focused on endings and completion and healing and letting go and forgiveness and letting go of shadows and addictions and facing the shadows of why I was engaging in escapism, blah, blah. I knew that that was setting the stage for the first house perfection year, which was all about.

and is, still in my first house perfection year, that is all about the self, the identity, appearance, energy, vitality, courage, leadership, self-concept. So I knew that that was coming. So that really helped me to navigate my 12th house perfection year and go as deep as I possibly could because I knew that I would be going from the depth of the oceans of my subconscious and my being and spirit to being in the sun once again with that first house perfection year.

And the deeper I could go the more liberated I would be in that first house perfection year to really carpe diem on what this year held for me. So my birthday was in February and that began my first house perfection year. On the day of my birthday I got my nose pierced. I used to have a septum ring for those who remember and know this. I used to have a septum ring which is the one that's in the middle of your nose. It's like the bull ring some people call it.

And I had that actually since like, might've even been my first house perfection year or my 12th house perfection year, like 10, 11, 12 years ago. Like I had it for a long time, the septum ring. And that was a big part of my identity actually, like in terms of looking at my face every day and always seeing that, you know, gold ring that never came out. And I decided to get rid of it.

Let that go and get my side nose ring pierced my nostril. And I love it. I personally feel it's just got this little rock and roll vibe that I'm just really into right now. I switched from yellow gold to platinum or is it? Yeah, it should be platinum or is it titanium? I think it's platinum. It's like the most luxury white gold kind of metal that I could go for. And that shift was literally day one of my first house perfection here.

I was like, let's celebrate this year that is about my appearance and my identity and the way that I take up space in this world right away with a new piercing on my face. And I am very happy about that decision. I love the way that it looks. And I'm just super stoked about the shift in my, I feel it like, you know, sometimes you shift your outsides and that does shift your identity in the way that you relate with yourself.

Because I did so much cleanups on my bad habits, basically, and anything I was doing that was like escapism, anything that was an addictive energy, whether it was smoking weed more frequently in the past or scrolling or shopping, the kind of escapism, tuning out, dissociation, things that I was engaging in, cleaning that up so much. And now it's so wild how in my first house perfection year, I feel like I have aged backwards because obviously I'm putting less of a tax and load on my organs and my body in terms of processing.

Even I switched to half-caff coffee in the morning. So I, it's half decaf beans with half regular caffeine. So I'm even just consuming less coffee. I'm just taking amazing care of myself. I have so much vital energy. Like I feel younger than I did when I was 26, for real. And I also just showed up a lot for my body, working out, showed up a lot for my self-concept and my identity in terms of identity work, journaling, EFT tapping.

Just installing more helpful beliefs in my system in the way that I'm relating to myself and being very aware that there would be a shift in identities this year. So also being conscious and aware of the stories I was telling and the things that I was identifying with. Like if you identify as someone who struggles, you're going to keep perpetuating struggle in your life. And it's not about not acknowledging the truth of your past experiences, but it's about not allowing that to become an identity.

Because we live from our identities and the actions we take come from that space and the opportunities we see are filtered through the lens of our identity as well. So I became a lot more limitless, I felt, in my identity and even shifting my identity from being a business owner more into artistry, more into being someone who's here to share a message with the world and that led to the change in my business and my brand. So we see that there's the new podcast Aquarian Age Business.

Seeing myself, my identity shifting to someone who's speaking on the Aquarian Age, not just a business coach, not just, I'm here helping people make money and make sales. We love that. We love abundance. We love sexy strategy and structure. And we love exalting our gifts with a sound business structure that has structural integrity with a business model that's actually like a thriving ecosystem. I love that. I love knowing how to do that. I love helping people do that, but that's not my identity.

That's not my mission. That's not the legacy that I care to leave behind. So I really saw how much I had become identified with my business, which makes sense. My business gave me so much in a really short period of time, all of a sudden making so much money from it, being recognized, having growing my audience and stuff. There was a lot, especially during the pandemic, you know, when I didn't have that much of a life outside of my business.

And I became very identified with that. I became identified with always having a higher revenue month than the month before and like all that kind of stuff. So I had to unwind a lot of that and realize because the first house is very passionate. So first house perfection year, it's about

doing what you want to do. And I realized I wanted to be more in my artistry. I wanted to spend more time dancing. I wanted to paint.

And I actually made my first two paintings this year that I'm really proud of. I definitely want to make another painting before the end of the year, because that identity is something that I always admired and respected. And the pages and like people on social media, for example, that I find the most inspiring that I respect and admire the most were not business coaches. They were artists. And sometimes those artists would obviously put out digital offers and programs, but they were still first and foremost an artist. And I had never seen myself as an artist.

I didn't have innate skills with a lot of things like drawing. Even my writing is just incredibly messy. I just like, didn't, my family, didn't have a lot of money and stuff for like extracurricular activities. Dance was my first art and I didn't even connect with that till my late twenties. So I started dancing more this year. I performed this year at a festival on stage in front of an amazing crowd to like really, really inspiring music, which was such a highlight for me.

I started writing a lot of poetry this year as well and I actually recited my poems at an open mic for the first time just like two weeks ago I think it was. So you know as we started getting to the end of the year I was like doubling down on what is this new identity I'm stepping into. It was not just the artist identity but the lover identity. Your girl is in her single and celibate era for a hot minute here which has been really profound and

That was also last year as well. Last year with the 12th House Energies, it was more like I am facing my relational shadows, attachment issues, doing the deeper healing on that. And it was a lot of tenderness and a lot of, there was a lot of wounds and distortions and lineage stuff. Like I went really deep with that.

And then this year, it's been more about living into the lover archetype in terms of the treatment that I'm available for. Being taken out to amazing places, having the standards and boundaries that I have, having an amazing time by myself, having so much fun with my community, romancing, romanticizing, hanging out with my girlfriends, me and six of other girlfriends went to see Avatar this weekend to celebrate my best friend's birthday. And we were like, you know, holding hands and resting our head on each other's shoulders and stuff like that.

Treating each other like one person got the popcorn, one person got the chocolate, like someone brought cacao in a thermos, just romanticizing life more. Even though I'm super single

and celibate at the moment, I was living into the lover archetype in terms of wearing clothing that I felt exalted my beauty, spraying beautiful natural perfumes that I felt like connected me to my sensuality and my pleasure, taking really good care of myself. Hair, body, sauna, dry brushing, working out and just getting in my body, listening to music that connect me to my sensuality.

Just bringing more of that into my life and letting, easing up the business owner success identity because there was a hardness to that. There was a self protection to that because it was so connected to security and survival. So the 12th house year helped me to untangle that and shift that at the deepest level because I knew what the greatest opportunity was and I knew the greatest opportunity was my healing. So I went all in on my healing.

Then with the first house perfection here, now that I created all this space and I healed all this wounding and I cleared all this distortion, it got to be, all right, who am I choosing to be now? Not looking at the past forever, not digging into the wounds and the subconscious mind and looking for problems to solve. I'm not a fucking problem to solve.

I am a radiant woman with a glowing, radiant heart full of so much love and passion, and this life is my artwork. And there are things that are not in my control, and there are things that I can choose and I can live into, and I can be in that creator energy. One, the number one is very much about the self and creation, right? It's being a creator. It's the first manifestation, and now what do I want to do? It's very much about what you want.

So things like, changing my schedule, changing my business model, changing how I'm showing up online to be less like, I'm a business coach, success, success, success, look how much money I made. And by the way, I find money wins to be relevant because I do work with entrepreneurs and one of their goals is growing their income almost always, growing their revenue, growing their income in ways that are aligned to their blueprint.

So it is relevant how much money that a business coach makes in my opinion. I would never hire a business coach who does not share their money and business achievements because why would I hire someone if I don't know what they've achieved? Why would I hire someone just because I like their posts? Like if they're doing support for business, I want to know what they've actually built and achieved. That's relevant information. So I'm not saying that that's just bad or wrong, but I'm saying that part of me was overly identified with that and I was not expressing and exploring and expanding on other parts of me that my soul deeply craved to be expressed...

Which was now the lover and the artist archetypes. And really living into that and being a creative force who's really listening to a flow and not only trying to create certain results. Where the strategy becomes the compliment to the essence, right? That's ultimately what even soul business is about deep down, right? So I got to really live into that. I made some very intentional purchases.

Even though on one hand I really shifted my relationship with spending and saving, I've grown my net worth so much through doing this, but also still making my select purchases that were like the artisan made silk, beautiful like recycled 14 karat gold, like that kind of vibe and just really showing up for my Vessel as a temple that I am adorning.

In this archetype, also of priestess as well, oracle, really stepping into that more and more and more and letting the business side of me be and still exist in the universe that I am. And I love that part of me, that part of me has achieved so much, but that part of me also feels a bit tired because it was functioning from this place of creating safety, which meant it still was on some level, even when I was making six figure months, it still was on some level coming from an energy of survival.

And in the lover and artist archetype, that is really what I dream to live as. And so the freedom of that, you know, going to Greece for a month, being in so much pleasure when it came to the food, the turquoise swimming in the turquoise waters, going to nine different islands, going to a wedding of two very passionate Scorpios who are renewing their vows and just like being around so much love.

going to the museums, I had like one or two calls on my schedule for the entire month of June and went to Greece. created that. Even though I could have made a bunch of money and worked while I was traveling too, but I just didn't want to. That wasn't my highest desire. So it was really about giving myself permission to want what I want, to be who I want to be in this world, to show up for adorning my temple and for my outer expression to reflect my essence in a way that was really authentic and healthy and just aligned to me.

I also, there was a time that I was considering Botox and injectables and during this year I really just made that line for myself that I as, hey, this could change one day, but at the moment I feel very decided and sure on not doing injectables or Botox at this moment. I'm not never gonna say never, never, never, never, but I'm pretty sure no. And I've just decided I'm just going to age

through radiance and grace and vitality and feeding into myself and investing that money instead toward other things.

So that was just a shift for myself and my identity as a woman who's now 36 and turning 37 in a couple of months, where I had to go deep on some of my own internalized ageism and just realize part of my identity is aging naturally actually. And that feels really good to me too. And I'm not saying that that's what people need to do.

But even letting my gray hairs grow out and letting them spiral in with my curls and thinking, wow, one day am I going to have all silver curls? just realizing there's an identity in that of just, I love myself, I love my vessel, and I am going to treat myself with love. And I'm going to take actions of caring for myself that are rooted in love. And that's part of the lover archetype too.

I didn't mean for this to be like such a personal share, but you guys really, really loved the 12th House Profecion year episode. So for people who are entering in their first House Profecion year, which means you're turning 36, 24, 12, I don't know if any 12 year olds are listening to this, 48. So it's a 12 year cycle, fifth, 60. This is a time of who is the, who are you showing up as in the world? What identity are you choosing? Live into that identity? How is your external vessel expressing who you are inside? How are you?

Shining the light of who you are externally so that others can see it. That's really what it's about. What is your leadership? What does courage mean to you? What risks are you taking? The first House Perfection year is very much about taking risks as well. So doing things like, you know, I almost didn't go and recite my poetry at the open mic, but I decided it's time. It's time to just be vulnerable. And I was really nervous, guys. It's funny because I've done public speaking in front of much bigger groups like Lightning - I was a headliner at Lightning in a Bottle Festival.

I've done public speaking in front of much bigger groups, and I was so nervous sharing my poetry in an intimate group. it was like, this was that vulnerability that's part of the risk that an artist takes. That's part of the risk that a lover takes as well. So I felt really proud of myself for doing that. And yeah, I was even painting. I definitely want to create one more painting by the end of this year. I want to start getting back into piano practice because I'm just learning beginner with piano and I bought a keyboard and stuff.

These are the things that make my soul feel very alive. And I know that that actually feeds into my business because it brings more inspiration into my business without needing to like chase after like, what's the next launch and da da da da da and actually just live my life to the fullest

and know that my business is a support and a compliment to what my real mission and inspiration are leading me to.

In February, I'll have a birthday again and I will turn 37 and that is the second house perfection year. And the second house perfection year has to do with self-worth, sensuality, groundedness, embodiment, as well as wealth in terms of financial security, material resources, et cetera. So those will be my goals in my second house perfection year.

I am going to be increasing my rate of savings. I'm going to be investing very wisely. I'm going to be doing a lot of embodiment work and probably more investments that have to do with embodiment rather than business strategy or that kind of support and shifting that. And that's why this year I did more investments that had to do with leadership and creativity than I did necessarily like business strategy investments.

So Solar Returns and the Profecion year are so, so incredibly game-changing and valuable. Following the greatest opportunities that they are reflecting to me has made every single year a miracle. When I look back at my 11th house perfection year, when I was 34, that's when I launched some of my biggest courses. That's when I had some of my most record-breaking amount of people in courses. That's the year of networking group programs and social media like our impact with groups and the collective.

My 10th house perfection year, which is when you're 33, aka the Jesus year, that's the year of legacy and that's the year of success. That was my highest grossing year in business. It was just shy of a million Canadian dollars in revenue in my 10th house perfection year. My ninth house perfection year, the year before that when I was 32, that was all about learning and travel. So I invested in every course I wanted, every mentorship I was curious about. I just opened my mind to all different things.

And it was so fun. And I started my business in my eighth house perfection year when I turned 31, which is all about death, rebirth and transformation as well as wealth. So it's pretty wild. I transformed from not being Oath Oracle to being Oath Oracle in that year. One of the greatest debts and rebirths, every aspect of my life dramatically changed in a very short period of time.

We're not together anymore, but that was my, you know, a very happy and loving and supportive and committed relationship, the longest relationship I've had. It's really, and the year before that, if we just keep going, right?

Was my sixth house perfection year when I was 29. And that was when I also started to dance and train more and train my body. And I also was doing a bunch of different side hustles and learning different skills before this was like the year before I started my business or maybe it was two years, but still around that time. So I could go on and on. Of course, it all keeps clicking into the perfection year. I could tell my whole life story and it will keep clicking into the perfection year.

It starts off with deep emotional clearing and lineage clearing, ancestral clearing. That is the full moon in cancer. Then we have the 2026 business forecast. We're looking ahead at the business and world trends and predictions for 2026. Super juicy. So the quantum resolution program, and then that completes with the new moon in Capricorn, which is later in January this year. So that's the true time that I manifest my New Year's goals is always with the new moon in Capricorn and it's later in January this year. We're doing a full-on moon manifestation session, master class, and guided meditation for the new moon in Capricorn to finish off the quantum resolution program.
